PROCUREMENT PLANNING AND RESEARCH

Recovered Organic Waste Products (ROWP)

Beginning January 1, 2022, SB 1383 requires cities and counties to procure annually a quantity of recovered organic waste products to meet their annual procurement target.

- Considered City's procurement target ROWP feasibility
- Attended procurement workshops and webinars
- Reviewed neighboring jurisdiction programs
- Formed an ROWP working group
- Identified the suitable ROWP for implementation
- Allocated SB 1383 Local Assistance Grant Program funds for procurement

Recycled Content Paper Procurement (RCPP)

Beginning January 1, 2022, SB 1383 requires jurisdictions to procure paper products, and printing and writing paper that consists of at least 30 percent, by fiber weight, postconsumer fiber.

- Connected with the City's Purchasing Division staff
- Discovered the vendors and City staff purchasers
- Met with all the vendors to confirm SB 1383 capabilities and operational practices
- Established SB 1383 Shopping Lists
- Prepared vendor workshops for City staff
- Created an SB 1383 specific Purchase Order


